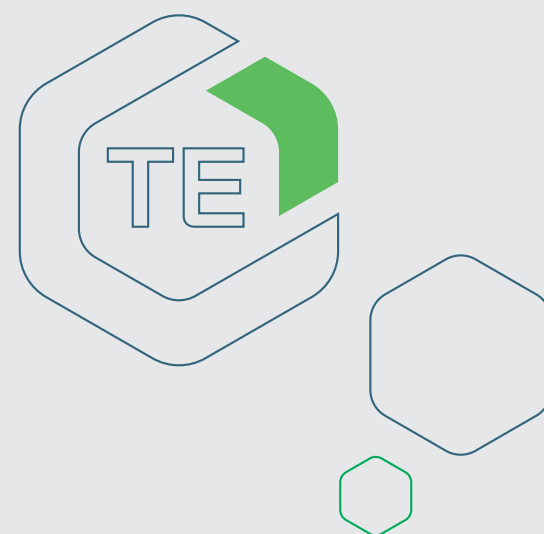


TOGETHER EVERGREEN

Production Standards & Circular Economy

Responsibility at every stage of product life (constant and ongoing monitoring):

- Modern Complex with installation solutions minimizing the risk of cross-contamination and emission of substances into the environment, including optimisation of process by concentrating them on one level of the Complex
- rational waste management and waste water reduction
- SZOK Recycling Program - active participation in the collection and environmentally safe disposal of returnable packaging
- increasing the share of packaging produced using recycled raw materials
- quality of packaging and original packaging - additional protection of products against impropere interference by third parties - continuation of the campaign „Legal plant protection products”
- use of biodegradable and renewable raw materials in products
- conceptual and product-based development of bio-trends thanks to a modern R&D resource base, including development of products supporting sustainable development
- Solar Farm - an increase in the share of Green Energy in the total amount used



Product responsibility

Sustainable Portfolio Plant Protection Products & Bio-solutions

Bio-responsible brand portfolio creation:

- until 2030, the brand Portfolio shall be expanded with bio-solutions: bio-fertilizers, biostimulators, soil improvers and biopesticides (development under strategic partnership agreements with the companies setting European and global BIO agricultural trends)
- building and placing on the market of product concepts to be used in the broadly understood plant protection, based on low-risk active substances as well as substances that do not have a harmful effect on human, animal and environmental health
- adjusting the current product portfolio to the assumptions of Circular Economy, including changing the design stage and ways of using new products
- promotion of product solutions approved for use in organic farming - chemical plant protection products (e.g. Miedzian 50 WP, Miedzian Extra 350 SC) and bioproduct
- partnership in research projects in the programs „Life’ and „Szybka ścieżka” („Fast track’)



Public awareness

Education & Transparency of Communication

Continued building and development of eco-awareness of PPE recipients and users through:

- promoting sustainable development activities - a dedicated website: www.synthosagro.com/sustainable-development
- educational films on the safe use of plant protection products - „Owocne dyskusje” („Fruitful discussions”) and „Z myślą o polskim rolniku” („For a Polish farmer”)
- active consulting - user-dedicated telephone to the Expert on Plant Protection Products
- training and meetings in orchards and fields - raising the awareness of fruit growers and farmers about the proper use of PPP and about their precise dosage
- promoting the monitoring of the amount of PPPs and active substances introduced into the environment - cyclical editions of the Treatment log books for fruit growers and farmers
- implementation of model Plant Protection Programs in cooperation with individual orchards and agricultural farms as well as experimental plants
